I AGREE in consideration for my participation in this Activity to the following:

I AGREE that I choose to participate voluntarily in the Activity with my horse, as a rider, driver, landler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Activity involve inherent dangerous risks or accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”).

I AGREE to release Black Walnut Enterprise LLC, Anna Savelesky, and their representatives (Facility) from all claims for money damages or otherwise from any Harm to me or my horse and for any Harm caused by me or my horse to others even if the Harm resulted directly or indirectly from the negligence of the Activity or Facility.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Activity or the Facility and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Activity. I have read the Facility and Activity Rules about protective equipment and I understand that I am to wear protective equipment without penalty, and I acknowledge that Facility strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and AGREE to all the above provisions and AGREE to assume all of the obligations of this Release on the child’s behalf.
